The Council for the Township of Killaloe, Hagarty and Richards met on the above date with Councillors Isabel O'Reilly, John Jeffrey, Ernie Cybulski, Stanley Pecoskie, Carl Kuehl and Debbie Peplinskie present. Mayor Janice Visneskie chaired the meeting, which she opened and called to order.

**<u>Pecuniary/Financial Interest:</u>** No Pecuniary/Financial Interest was declared by any of the Council members present.

#### Minutes:

**Delegations:** Kim Barnes was present and was invited to address Council. She asked for and received approval to operate her chip truck again this year on municipal property adjacent to the Tourist Information Booth. Ms. Barnes thanked Council for their attention to her request, and left the meeting.

**Reports:** Works Superintendent Clifford Yantha was present and was invited to give his report. A co-op student from MVDHS will be starting with the Works Department on February 5<sup>th</sup>.

## **CAO/Clerk-Treasurer:**

Moved by Carl Kuehl Seconded by Stanley Pecoskie

THAT WHEREAS the Council for the Township of Killaloe, Hagarty and Richards passed Resolution #2, dated February 5, 2002, to retain the one-third tax free allowance for remuneration for Council members;

AND WHEREAS this resolution has not been revoked, and as such, is deemed to be a by-law of the municipality;

AND WHEREAS pursuant to Section 283(7) of the Municipal Act, 2001, Council shall review this by-law at least once during the four-year term of Council;

NOW THEREFORE BE IT RESOLVED THAT the Council for the Township of Killaloe, Hagarty and Richards wishes to retain the one-third tax-free allowance for remuneration of Council members. Carried.

## **Committee Reports:**

**Waste Management Committee:** Councillor Cybulski reported that he and Mayor Visneskie had attended a meeting with representatives from Madawaska Valley Township to discuss recycling strategies and to explore areas where it may be possible to share services. He also advised that the subcommittee members had participated in a teleconference call with two representatives from MOE relating to questions that the committee members had regarding waste export. The next sub-committee is scheduled for February 7, 2011 at 9:00 AM. The CAO/Clerk-Treasurer was asked to invite Tyler Peters of Greenview Environmental to attend.

**Recreation Committee:** Councillor Cybulski advised that there is an issue with the door at the Killaloe Rink, and that he will look at a possible solution to this. Council congratulated Councillor Kuehl and the other volunteers for preparing the ice at the Killaloe Rink. Councillor Kuehl advised that there are minor repairs required in the washrooms at the rink, and that he has contacted a plumber in this regard.

**Finance Committee:** A Finance Committee meeting is scheduled for February 22, 2011 at 6:30 PM.

**Other Committees:** Councillor Cybulski advised that he and the By-Law Enforcement Officer had reviewed the animal control by-law, and will prepare a draft of amendments for the By-Law Review Committee.

Councillor Pecoskie reported that he had attended the most recent CPAC committee meeting. The discussion at the committee centered on the large increase in annual policing costs that will be charged to municipalities. All of the municipalities represented at the CPAC meeting agreed that they want to have a meeting with the representatives from the OPP about this issue. Staff Sergeant Dowdall is working on the 2011 OPP business plan and asked for input from local councils in the catchment area. The committee also discussed the ramifications of hand-held devices legislation.

Mayor Visneskie reported that the County Health Committee has asked County Council about the possibility of having a County Wide emergency plan exercise, involving all seventeen municipalities. The Emergency Services Director has been authorized to prepare a plan and budget for presentation to County Council in this regard.

Mayor Visneskie also reported that OVTA had made a presentation to County Council and have issued a challenge to get more membership and involvement from businesses in the communities. OVTA is introducing a membership recruitment challenge and wants municipal councils to encourage their businesses to join OVTA. She forwarded the information relating to this initiative to the Chair of the Economic Development Committee.
